Jazzercise: called Aerobics on calendar. Jazzercise has 5 scheduled times on the calendar. 8:00 am classes occur on Tuesdays, Thursdays and Saturdays. 5:45 pm classes occur on Mondays and Thursdays. The district does not pay for these classes. Residents are asked to pay a fee for Tuesday and Thursday morning classes (I believe its \$3.00 per class). Jazzercise is routinely paid by membership. Trailer Estates is the listed site for this class. The current service agreement for Jazzercise ends in January 2024. We do have a service agreement completed by the former trustee but it has not been signed by the Jazzercise instructor.

Line Dance: Line Dance is scheduled every Tuesday at 5:30pm. District does not pay the instructor. The participants' fee is not included in the current service agreement.

Yoga: Yoga is scheduled every Tuesday and Thursday from 9:15-10:30. There is a \$75.00 fee for each session (District pays \$40.00, participants pay \$5.00 per session).

Chair Yoga: Chair Yoga is scheduled every Wednesday and Friday from 9:00-10:15. District does not pay the instructor (who is a TE resident). The participant's fee is not included on the current service agreement.

Dancin' for Fitness: Dancin' for Fitness is scheduled every Monday and Wednesday at 12:15. There is a \$60.00 fee for each session (District pays \$30.00 and participants make up the remainder). The participants' fee is not included in the current service agreement.

Couples Line Dance: Couples Dance is scheduled every Wednesday at 1:00. The fee is \$100.00 per session. (District pays \$50.00 and participants make up the remainder.) The participants' fee is not included in the current service agreement. We do have a service agreement completed by the former trustee but it has not been signed by the instructors.

Dear Trailer Estates Community Leaders (and/or Sandy),

I hope this message reaches you well! This is Brandy Gray, Yoga Instructor at Trailer Estates for Spring season. Thank you so much for welcoming me to be a part of the family at Trailer Estates! I am so honored to be able to connect with such a great group of human beings, and have the opportunity to grow together in our practice. I've thoroughly enjoyed the last 4 or 5 years, and look forward to the years ahead!

I received your proposed contract in the mail for next spring, and I see that it extends through May next year, which is great, but I had hoped to meet in person because I planned to request changes for consideration.

As of January 2023, my rates have increased from \$50/class as my default standard to \$75+/class as result of investing in and completing my recent certification (one year long training) from RYT200 (standard requirement) to RYT500, which means I have completed the highest international standard of yoga education available.

I am certified in Senior Yoga, Chair Yoga, Restorative Yoga, and several other styles that place my expertise and education well beyond average. I also work with seniors exclusively and have several years experience in supporting senior-well being & quality of life, and accommodating issues/conditions/injuries commonly related to the aging experience.

I also bring and provide all my own sign-in sheets, props, blankets, blocks, straps, and other tools and supplies to ensure comfort and safety of all students and guests, and to promote maximum benefits of practice.

To add, I also travel 45 minutes each way (1.5 hours of travel) to teach this class (which is well worth it because I love this community!)

Please note, I provided a copy of the contract to propose my requests for consideration, including increasing my pay to \$40 per class (vs \$25) from Trailer Estates, and the remaining sum paid by class students. (please see the provided document for review!)

I would also like to inquire about teaching a "Chair Yoga" class following the "Gentle Yoga" class on Tues/Thursdays, both to make the most of my time and travel, and most importantly, to fulfill the needs of the community, since there is a genuine demand for Chair Classes for those who are unable to manage a full standing practice.

This has been asked of me many times in the past several years and it's something I'd like to bring to your attention for consideration to add to next year's schedule. (I also know Jim Angerame teaches Chair Yoga so I am not sure if this is something you would consider in addition to his classes). This class would be same cost as the other immediately following the first one, (1045-1145am) if this would be something of interest to you and your community! (I included an additional copy of contract with this class in place in case it would be of interest! If not, please ignore it!)

Please let me know your thoughts upon receipt! I truly appreciate the opportunity to teach at Trailer Estates, it's been a major highlight of my teaching journey, and a blessing to my life!
